

Community Land Management Plan

Banksia Park

**Marsha Reserve, Jasper Reserve, Oleander Reserve,
Shannon Reserve, Huon Reserve, Butler Reserve, Tay
Reserve, Brightlands Reserve, Gunda Reserve**

Description

Identity of land the subject of this plan:

Marsha Reserve (20)

Lot 116 in Deposited Plan 7359, being the land contained in Certificate of Title 5873/759, bounded by Marsha Drive and Oleander Drive. The attached plan identifies the location of the land. The land comprises a playground, signage, metal seat/bench, bin, gravel footpath and is set in a bushland comprising several large trees.

Jasper Reserve (21)

Lot 10 in Deposited Plan 9802, being the land contained in Certificate of Title 4009/345, bounded by Hancock Road. The attached plan identifies the location of the land. The land comprises natural grasses, trees, natural creek and stormwater outlet, wire fencing, reserve furniture such as a park bench.

Oleander Reserve (22)

Lot 99 in Deposited Plan 8020, being the land contained in Certificate of Title 2905/146, Lot 76 in Deposited Plan 6926, being the land contained in Certificate of Title 2769/128, bounded by Oleander Drive and School Drive. The attached plan identifies the location of the land. The land comprises a grassed area with irrigation, dolomite footpath and signage.

Shannon Reserve (16)

Lot 256 in Deposited Plan 6909, being the land contained in Certificate of Title 2754/90, bounded by Shannon Rise, Grenfell Road and Hobart Crescent. The attached plan identifies the location of the land. The land comprises natural grasses, trees, natural creek with stormwater outlet, signage, playground, dolomite footpaths, pedestrian bridge, reserve furniture such as park bench and bin.

Huon Reserve (17)

Lot 43 in Deposited Plan 7229, being the land contained in Certificate of Title 2754/89, bounded by Huon Street and Burnie Street. The attached plan identifies the location of the land. The land comprises a shaded playground, basketball ring, grassed area, a seat and drinking fountain, gravel footpath, signage and a small landscaped area.

Butler Reserve (18)

Lot 6 in Deposited Plan 8280, being the land contained in Certificate of Title 2727/63, bounded by Hancock Road. The attached plan identifies the location of the land. The land comprises natural grasses, trees, natural creek and stormwater outlet.

Tay Reserve (24)

Lot 22 in Deposited Plan 10566, being the land contained in Certificate of Title 5736/852, bounded by Haines Road and Milne Road. The attached plan identifies the location of the land. The land comprises natural grasses, trees, natural creek and stormwater outlet, wire fencing, bitumen and concrete footpath, reserve furniture such as a park bench.

Brightlands Reserve (4)

Lot 412 in Deposited Plan 9142, being the land contained in Certificate of Title 3571/181, Lot 413 in Deposited Plan 9142, being the land contained in Certificate of Title 3571/181, Lot 410 in Deposited Plan 9142, being the land contained in Certificate of Title 3571/181, Lot 32 in Deposited Plan 9709, being the land contained in Certificate of Title 1545/171, Section 2296 in Deposited Plan 9709, being the land contained in Crown Record 5764/701, Lot 411 in Deposited Plan 9142, being the land contained in Certificate of Title 3571/181, Lot 414 in Deposited Plan 9142, being the land contained in Certificate of Title 3571/181, bounded by Milne Road and Haines Road. The attached plan identifies the location of the land. The land comprises natural grasses, trees, natural creek with stormwater outlet, permapine fencing, pedestrian bridge, dolomite footpaths and signage.

Gunda Reserve (6)

Lot 20 in Deposited Plan 8316, being the land contained in Certificate of Title 3374/42, Section 2295, being the land contained in Crown Record 5764/700, Lot 288 in Deposit Plan 9138, being the land contained in Certificate of Title 3571/180, Lot 59 in Filed Plan 132650, being the land contained in Certificate of Title 5861/553, Lot 290 in Deposited Plan 9137, being the land contained in Certificate of Title 3571/180, bounded by Grenfell Road, Gunda Road and Waitara Road. The attached plan identifies the location of the land. The land comprises a large open grassed area, raised mounds to configure a BMX track, shaded playground, basketball ring, park bench, bin, small landscaped area, permapine and wire fencing, signage, a dolomite pathway and some stormwater headwalls/culverts.

Purpose

Council retains this land for the following purposes:

The Council is required by Section 7 of the Local Government Act 1999 to “provide services and facilities that benefit its area, its ratepayers and residents and visitors to its area, including amongst other things recreational facilities”. This land is retained by Council to provide passive recreation facilities for the community and other visitors. The casual hire of these reserves can be arranged by contacting Council’s Call Centre 8397 7444.

The land is not otherwise the subject of any formalised lease or licence. Council may grant a lease or licence of the whole or any part of the land during the life of this management plan.

Council will consider the land in regards to it being suitable for the purpose and may with its powers under Council’s By-Laws restrict or prevent activities that are considered to be inappropriate for the land.

Objectives

Council’s objectives for managing this land are as follows:

The Council seeks to ensure that all of its assets are utilised to their maximum potential. In particular the land serves to meet the Council’s desire that residents are able to partake in a range of activities to achieve a balanced life incorporating recreation opportunities.

Management Proposal

These are the Council's proposals for managing this land:

The land comprises natural grasses and trees, grassed area, irrigation, landscaping, natural creek and stormwater outlet, drainage swale, permapine and wire mesh fencing, concrete, paved, bitumen and dolomite footpath, BMX track, shaded playground, basketball ring, pedestrian bridge, lighting, reserve furniture such as park bench, gazebos, bin, drinking fountain and lights.

1. Grassed area

The grassed areas are currently equipped to satisfy the needs of regular users. As required, controllers and sprinklers are replaced or repaired to maintain a service standard consistent with its existing use. The sites are regularly mowed and watering occurs in accordance with the Code of Practice for Irrigated Public Open Space as regulated by SA Water.

2. Landscaping

Some reserves are partly irrigated to landscaped garden beds and grassed areas. Most contain mature trees and native grasses and Council Staff attend to the upkeep of these properties by conducting horticultural maintenance practices such as mowing, weeding, pruning, irrigation repair/management, etc.

3. Playground & BMX track

Shaded play equipment where installed is regularly inspected to check that the fittings and fixtures are mechanically sound. The soft fall area is inspected and re-levelled regularly including raking and topping up annually. The BMX track on Gunda Reserve is inspected and maintained when applicable.

4. Fencing

Reserve boundary fencing adjacent to residential or commercial properties are not managed or maintained by Council in accordance with the Fences Act 1975. Fencing rails or panels at other sites independent of "boundaries" are repaired or replaced to ensure that they are structurally sound and suit the intended purpose.

5. Reserve Furniture & Signage

Park benches, bins, drinking fountains and signage (where provided) are common features within these reserves. This equipment is checked on a regular basis to establish that the fixtures and fittings are mechanically sound and suit their intended purpose. Plumbing, painting and carpentry improvements will be carried out as required to ensure the robust nature of these fixtures.

6. Footpaths

Footpaths within these reserves are formed of dolomite. Defects in the footpaths are often reported by local residents and through the "Customer Response Management" system, Council will then attend to its repair. Tripping hazards are also recorded via Council resources and as required will either be replaced or repaired.

7. Pedestrian Bridge

Hand rails, decking timber and other structural elements such as abutments are inspected on a regular basis to check the fittings and fixtures are mechanically sound. As required, painting and carpentry work is carried out to ensure the safety of these bridges.

8. Creek Maintenance

Watercourses and creeks generally are inspected on a regular basis for the management of weed growth and pollutants. It may be necessary to carry out earth works to address erosion.

9. Stormwater Outlet and Culvert

Council regularly inspects stormwater outlets, culverts and side entry pits to remove any potential blockages and carry out repairs as necessary to minimise the risk of flooding.

Council has a regular maintenance schedule, which is reviewed prior to the setting of the Council's annual budget. The schedule provides for the Council's staff to attend to the upkeep of the land in a reasonable fashion bearing in mind the requirement on Council to attend to the management of its other City wide assets.

Subject to compliance with the requirements of all relevant legislation the Council may, during the life of this management plan, develop the land by erecting buildings or structures which will enhance the use of the land as a recreation facility.

Other Government Policies

The land is in the Residential Tea Tree Gully Zone or Golden Grove Residential Zones.

The Council's Development Plan governs what activities may occur on the land and how it may be developed during the life of the Plan.

The Council has adopted by-laws which effect and regulate activities on Councilland:

- The Council's "Dogs" by-law
- The Council's "Roads" by-law
- The Council's "Local Government Land"

Performance Appraisal

The Council will measure how it has managed the land in the following ways:

The Council regularly undertakes community consultation studies and surveys and will include a request that respondents comment on their views of and experiences in using the land. In addition the Council invites people to comment to the Council via its website, by post or facsimile, in person at the Council offices and by telephone.

The Council will record all complaints and compliments and attend to those requiring action. In addition complaints and compliments will be reported on annually at a meeting of the Council.

The Council has adopted a performance management system to record successful achievement of employee functions. Regular assessment and reporting of compliance with the Council's asset maintenance programme is integral to this process.

As part of the horticultural management of the land the Council will carry out "random anonymous audits" to measure whether the Council is meeting its objectives expressed in its management schedule. The Council will review this Management Plan within 5 years of the date of its adoption and as appropriate amend maintenance as required.

Development

There are no immediate plans to develop these sites.

Council can, however, consider any future development on each site beyond the 2014/2015 financial year, in particular the removal and/or replacement of above ground infrastructure and equipment until the expiry of the Management Plan. Any development will be subject to future budget bids and consultation with the Community.
