Under section 70(a1) of the Local Government Act 1999 ("the Act"), the council must publish on the website the following details about a council member as recorded in the Register of interests:

- * the member's income sources (within the meaning of Schedule 3 of the Act) or employer;
- * the name of any political party, any body or association formed for political purposes or any trade or professional organisation (within the meaning of Schedule 3 of the Act) of which the member is a member;
- * any gifts received by the member that are required to be included in the information entered in the Register in relation to the member.
