- 3. Requests the Council's staff continue to negotiate and present options to clarify the transition arrangements to ensure all currently connected Community Wastewater Management Scheme properties are transferred to become SA Water customers from or before 1 July 2022.

- 4. Requests the Deputy Mayor to write to the Minister, Environment and Water to request an urgent meeting to address current unresolved matters which appear to be beyond SA Water's current authority in particular the acquisition of Council's Community Wastewater Management Scheme properties from or before 1 July 2022.
- 5. Requests the Deputy Mayor to write to the Leader of the Opposition to provide a copy of the letter sent to Minister, Environment and Water.
- 6. Requests the Deputy Mayor to write to all local members of parliament under the new electoral boundaries (to commence from the 2022 State Government elections) to advise them that it is Council's preference to modify the transition plan to accommodate point 3 above to avoid the need for all general ratepayers in the City of Tea Tree Gully to be levied an additional 2.5% rate rise to fund the additional operating costs and losses of the Community Wastewater Management Scheme throughout the duration of SA Water's proposed transition period which is currently planned to be over an 8 year period.
