 - b. Dogs are to be permitted on or off leash when
 - the oval is not being used by the Tea Tree Gully Primary School or Kathleen Mellor Preschool Kindergarten and children are not present or

- ii. the oval is not being used under a formal hire agreement to a sporting club.
- c. The requirement for dogs to be put on a leash and to move immediately off the oval would come into effect when the School's staff and students move onto or cross the oval and when school children are present between 8am and 4pm Monday to Friday, school terms; or when sporting clubs are accessing the oval under a formal hire agreement.
- d. The matter be returned to Council earlier if the trial arrangements are adversely impacting the licence agreement, School or a hire agreement with a sporting club.
- 2. The Council request the Chief Executive Officer to write to the Minister for Education (or their delegate), with a copy to be provided to the Tea Tree Gully Primary School Principal and Kathleen Mellor Preschool Kindergarten Director to confirm the trial and associated conditions seeking the Minister's formal approval of the trial as a variation to the current licence agreement.
- 3. That Council in relation to <u>Council's By-Law No. 4 Dog's</u> amend the following condition to the Dogs off Leash Areas and in relation to the Tea Tree Gully Sports Area (Memorial Oval), Tea Tree Gully:

Dogs off leash are permitted at all times with the requirement for dogs to be put on a leash and to move immediately off the oval when Tea Tree Gully Primary School or Kathleen Mellor Preschool Kindergarten staff and students move onto or cross the oval and when are present between 8.00am and 4.00pm Monday to Friday, during school terms or when sporting clubs are accessing the oval under a formal hire agreement.

- 4. That Council erect signage at the Tea Tree Gully Sports Area notifying of the ability for Dogs off Leash on Memorial Oval and communicating the requirement for shared usage, as per the above condition stated in Item 3 above.
- 5. That a sum of \$4k be added to the relevant 2021-22 Financial Year operating budget for the purpose of amending signage at the Tea Tree Gully Sports Area and development of education flyers in relation to dogs being permitted off leash and the associated access conditions for Memorial Oval, Tea Tree Gully.
- 6. That the Chief Executive Officer be requested to bring a report to Council prior to the conclusion of the trial period that reports on the outcomes of the trial and any recommended future proposal of dogs being permitted on and/or off leash at Memorial Oval, Tea Tree Gully.

Leave of the meeting was sought with the consent of the mover and seconder to vary the motion to remove the words "and children are not present" at the end of section 1.b.i. Leave was granted.

The Council request the Chief Executive Officer to write to the Minister for Education (or their delegate), with a copy to be provided to the Tea Tree Gully Primary School Principal and Kathleen Mellor Preschool Kindergarten Director to confirm the trial and associated conditions seeking the Minister's formal approval of the trial as a variation to the current licence agreement.
- That Council in relation to <u>Council's By-Law No. 4 Dog's</u> amend the following condition to the Dogs off Leash Areas and in relation to the Tea Tree Gully Sports Area (Memorial Oval), Tea Tree Gully:

Dogs off leash are permitted at all times with the requirement for dogs to be put on a leash and to move immediately off the oval when Tea Tree Gully Primary School or Kathleen Mellor Preschool Kindergarten staff and students move onto or cross the oval and when are present between 8.00am and 4.00pm Monday to Friday, during school terms or when sporting clubs are accessing the oval under a formal hire agreement.

- 4. That Council erect signage at the Tea Tree Gully Sports Area notifying of the ability for Dogs off Leash on Memorial Oval and communicating the requirement for shared usage, as per the above condition stated in Item 3 above.

That a sum of \$4k be added to the relevant 2021-22 Financial Year operating budget for the purpose of amending signage at the Tea Tree Gully Sports Area and development of education flyers in relation to dogs being permitted off leash and the associated access conditions for Memorial Oval, Tea Tree Gully.
