Mr Mark Booth, Director BRM Advisory provided an update on the City of Tea Tree Gully Section 48 Prudential Report: CWMS Transition to SA Water.

# 10.2. Community Wastewater Management System (CWMS) Prudential Report update and request to provide draft report to SA Water and Minister for Environment and Water (D21/93627)

Pursuant to sections 75 & 75A of the Local Government Act 1999, Crs Jones and Lintvelt declared an actual conflict of interest in relation to this matter on the basis that they both have a Community Wastewater Management System (CWMS) connection on their properties. Crs Jones and Lintvelt left the meeting and its close vicinity at 9.00pm while the matter was being discussed and voted on.

Pursuant to sections 75 & 75A of the Local Government Act 1999, Cr Savvas declared a perceived conflict of interest in relation to the matter on the basis that she is an candidate for the upcoming State Election for the seat of Newland, noting transition of CWMS is a matter relevant to the State election. # 10.2 Community Wastewater Management System (CWMS) Prudential Report update and request to provide draft report to SA Water and Minister for Environment and Water (D21/93627)

Suspension of formal meeting procedures at 9.04pm

- 1. That Council, having considered the report titled "Community Wastewater Management System (CWMS) Prudential Report update" and dated 16 November 2021 and following a request from the Minister Environment and Water, Hon David Speirs, resolves that Council provides a copy of the draft Community Wastewater Management System (CWMS) Prudential Report to the Minister and SA Water to invite comment and seek amendments to the current SA Water City of Tea Tree Gully Sustainable Sewers Plan, in particular to:
  - a. address the decommissioning costs/responsibility to ensure that householders will not have to pay anything for the conversion to sewer as per the Minster's commitment.
  - b. address the inequity within the current SA Water City of Tea Tree Gully Sustainable Sewers Plan where households converted in the early stages of the project will have a major advantage compared to those being converted in the latter years where this inequity is of the order of at least \$400 per property per annum.
- 2. That Council advises the Minster for Environment and Water that Council is prepared, subject to 1. A. above, to realign Council's future works program to support the SA Water's Sustainable Sewers Program. This will include:
  - Street tree planting
  - Road resealing
  - Road reconstruction
  - Kerb and gutter

- Footpath replacement and upgrades
- Incorporation of water sensitive urban design features into streetscape
- Other beautification opportunities
- 3. That the Minister be requested to provide a response by no later than 1 December 2021 to enable the finalisation of Council's prudential report for Council's consideration at the Council meeting scheduled for 14 December 2021.
- 4. That the Minister and/or his delegate be invited to attend the Council meeting when the Prudential Report is considered by Council.
