PURPOSE

To provide Council with an opportunity to consider a response in relation to Mayor Kevin Knight's behaviour and public comments to media made on 19 April 2021.

RECOMMENDATION

That Council, in response to Mayor Kevin Knight demonstrating poor leadership in his comments and actions in responding to the media on 19 April 2021, takes the following action:

- (a) Moves a vote of no confidence in Mayor Knight as Mayor.
- (b) Requests Mayor Knight make a public apology regarding his response to the media within two (2) business days.
- (c) Requests Mayor Knight to resign from his elected position as Mayor of the City of Tea Tree Gully by close of business Friday 23 April 2021.
- (d) Requests the Deputy Mayor to write to all known community groups, sporting clubs, schools, kindergartens, churches and similar within the City of Tea Tree Gully, advising that Mayor Kevin Knight is not Council's preferred representative at any community group or Council function and that they are respectfully asked that all official invitations to the City of Tea Tree Gully should be for the Deputy Mayor or the Deputy Mayor's nominee to represent Council.
