The public interest in the public access to the meeting has been balanced against the public interest in the continued non-disclosure of the information. The benefit to the public at large resulting from withholding the information outweighs the benefit to it of disclosure of the information. The Council is satisfied that the principle that the meeting be conducted in a place open to the

public has been outweighed in the circumstances on the basis that members of the public are not to be included in matters involving third party agencies where this information has been requested to remain in confidence.

22.1 Third Party Final Report - 2021/01843 (D22/183216)

Crs S Keane and Foreman left the meeting at 8.48pm.

Pursuant to sections 73 & 74 of the Local Government Act 1999, Mayor Knight declared a material conflict of interest in relation to the matter on the basis that he may be involved in the matter. He left the meeting and its close vicinity at 8.49pm and did not return for the remainder of the meeting.

Deputy Mayor Jones took the chair as Presiding Member at 8.49pm.

Crs S Keane and Foreman re-entered the meeting at 8.50pm.

Pursuant to sections 75 & 75A of the Local Government Act 1999, Cr Unger declared a perceived conflict of interest in relation to the matter on the basis that he may have participated in the investigation process. He indicated he would deal with the matter in a transparent and accountable way by leaving the meeting while the matter was discussed and voted on.

- Notes the final report from the Ombudsman dated 24 October 2022 regarding conduct of Mayor Kevin Knight as provided in Attachment 2 of this report.
- 2. Advises the Ombudsman that Council accepts the final findings and recommendations which states:
 - "Mayor Knight's decision to not issue an apology as set out in paragraph 4(a) of Resolution 388 of the council's meeting of 24 March 2020 does not amount to misconduct under Part 3 of the Code of Conduct; however, it does amount to a breach of Part 2.6 of the Code of Conduct

- Mayor Knight's failure to attend sexual harassment in the workplace training as set out in paragraph 4(d) of Resolution 388 of the council's meeting of 24 March 2020 amounts to misconduct under Part 3 of the Code of Conduct.
- Mayor Knight has engaged in repeated or sustained inappropriate behaviour, as listed in Part 2 of the Code of Conduct, amounting to misconduct under Part 3 of the Code of Conduct.

In doing so Mayor Knight has breached the provisions of section 63 of the Local Government Act.

To remedy these errors, I recommend pursuant to section 25(2) of the Ombudsman Act and section 263B(1)(d) of the Local Government Act that the council:

- 1. Ensure that a complaint is lodged against Mayor Knight with the South Australian Civil and Administrative Tribunal (SACAT) for:
 - a. failure to issue an apology as set out in paragraph 4(a) of Resolution 388 of the council's meeting of 24 March 2020, a breach of Part 2.6 of the Code of Conduct
 - b. engagement in repeated and sustained inappropriate behaviour as listed in Part 2 of the Code of Conduct which amounts to misconduct under Part 3 of the Code of Conduct for Council Members".
- 3. Notes that a complaint must be lodged against Mayor Knight in the South Australian Civil and Administrative Tribunal (SACAT) by the Chief Executive Officer who is empowered to lodge such complaint in accordance with section 264(1)(b) of the Local Government Act 1999.
