- 1. That Council notes that having investigated the alleged breach of the Code of Conduct for Council Members (Code), Ms Sue Porter from EMA Legal (as the External Investigator appointed by the LGA Governance Panel) finds that Mayor Knight, in relation to the allegations raised, has breached:
 - a. clause 2.2 of the Code in respect to Complaint C
 - b. clause 2.6 of the Code in respect to Complaint C
 - c. clause 2.7 of the Code in respect to Complaint A
 - d. clause 2.9 of the Code in respect to Complaint A and the reasons for these finding are outlined in the final Investigation Report provided as Attachment 1 to the report.
- 2. That having considered the final Investigation Report, Council makes a preliminary finding that Mayor Knight's conduct was in breach of:
 - a. clause 2.2 of the Code in respect to Complaint C
 - b. clause 2.6 of the Code in respect to Complaint C
 - c. clause 2.7 of the Code in respect to Complaint A
 - d. clause 2.9 of the Code in respect to Complaint A
- 3. That Council informs Mayor Knight of its intention, subject to any comment he may wish to make, to request he make a public apology to Council for his conduct.
- 4. That Mayor Knight be invited to provide a written response to Council's Chief Executive Officer, to present to Council, on Council's preliminary findings and proposed action within five (5) business days of being advised of this decision and this response be presented to the next meeting of Council for Council to make a final determination.

 - information the disclosure of which would, on balance, be contrary to the public interest .
 - o release of this information would divulge information provided on a confidential basis by a public authority, being the Local Government Association (LGA) before it is provided to the Minister for Local Government for approval.
- 3. In addition, the disclosure of this information would, on balance, be contrary to the public interest. The public interest in the public access to the meeting has been balanced against the public interest in the continued non-disclosure of the information. The benefit to the public at large resulting from withholding the information outweighs the benefit to it of disclosure of the information. The Council is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances on the basis that Council should to be able to communicate on a confidential basis with the LGA about proposed training standards for council members and thereby act cooperatively with the LGA in achieving positive outcomes for the local government sector.

1. Consultation for LGA Training Standards for Council Members

That Council, having considered the report titled "Draft LGA Training Standards Consultation and Elected Member Training and Development Plan for 2022-2023" and dated 26 July 2022, endorses Council's submission to the Local Government Association as provided in Attachment 2 of the report.

- 2. Elected Member Training and Development Plan for 2022-2023
 - a. That Council authorises the Chief Executive Officer to prepare and consider the Elected Member Training and Development Plan for 2022-2023 noting that the consultation for the proposed LGA Training Standards will impact this Plan being provided to Council for consideration in a timely manner.
 - b. That in preparing the plan, the Council supports the following approach to be taken into account:
 - i. These sessions will be called Elected Member Workshops and where scheduled, will generally be held on the first and/or third Tuesday of a month (depending on the Council and Committee meeting schedule endorsed by the newly elected Council) noting that the Chief Executive Officer has discretion to cancel or include additional Workshops if required
 - ii. Elected Member Workshops will not occur on the first Tuesday in November and be limited during the months of December or January, unless specifically required.
