Adoption of the Valuation of Land for the Purpose of Rating for the Financial Year Ending 2023

<u>Declaration of Differential General Rates and Minimum Amount for the Financial Year</u> <u>Ending 2023</u>

a) That pursuant to the provisions of Sections 153(2), 153(1)(b) and 156(1)(a) of the Local Government Act 1999 and consistent with the prescribed categories of land use set out at Regulation 14(1) of the Local Government Act (General) Regulations 2013, Council declares differential general rates based on the capital values of rateable land for the financial year ending 30 June 2023, as follows:

b) That pursuant to Section 158(1)(a) of the Act, Council fixes a minimum amount of \$1,280 payable by way of general rates on rateable properties within the area of the City of Tea Tree Gully.

## <u>Declaration of Separate Rates for the Financial Year Ending 2023</u>
