 - on the basis that the public release of this information would have the potential to impact the capacity to compromise Council achieving the best outcome for Council and the Community.
- 3. In addition, the disclosure of this information would, on balance, be contrary to the public interest. The public interest in the public access to the meeting has been balanced against the public interest in the continued non-disclosure of the information. The benefit to the public at large resulting from withholding the information outweighs the benefit to it of disclosure of the information. The Council is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances on the basis that early release of this information could

compromise Council achieving the best outcome for Council and the Community.
