 - information the disclosure of which could reasonably be expected to confer a commercial advantage on a person with whom the council is conducting, or proposing to conduct, business, or to prejudice the commercial position of the council; AND information the disclosure of which would, on balance, be contrary to the public interest; AND
 - commercial information of a confidential nature (not being a trade secret) the disclosure of which could reasonably be expected to prejudice the commercial position of the person who supplied the information, or to confer a commercial advantage on a third party; AND the disclosure of which would, on balance, be contrary to the public interest; AND

- tenders for the supply of goods, the provision of services or the carrying out of works.
 - o On the basis that release of this information has the ability to directly impact Council's ability to negotiate the best value for money for the community as well as impact the potential contractors ability to commercially negotiate contracts with third parties while the process is underway.
- 3. In addition, the disclosure of this information would, on balance, be contrary to the public interest. The public interest in the public access to the meeting has been balanced against the public interest in the continued non-disclosure of the information. The benefit to the public at large resulting from withholding the information outweighs the benefit to it of disclosure of the information. The Council is satisfied that the principle that the meeting be conducted in a place open to the public has been outweighed in the circumstances. That Council is satisfied that the principle that the meeting should be conducted in a place open to the public has been outweighed in relation to this matter by the need to keep the discussion of this matter confidential because early release of this information has the ability to directly impact Council's ability to negotiate the best value for money for the community as well as impact the potential contractors ability to commercially negotiate contracts with third parties while the process is underway.
